New Business

a. Rules - Susan with new local rule concerning sprinkler heads around greens. Sprinkler heads are obstructions. You may take relief if they inhibit your stance, ball or area of intended swing. However, if you are playing a course with closely mown areas around the green and elect to putt, the rules also allow for implementation of the local rule. You are entitled to free relief if a sprinkler head is located within two club lengths from the edge of the putting green, or within two club lengths of your ball or in your line of play. To take relief, find a spot that is within one club length of your ball's original spot and no closer to the hole where the sprinkler head is no longer in your line of play. Then drop your ball and play on.

This local rule has already been adopted by AGA and the Southern Disstrict.
